6. All notes (including notations made on records) relative to the deponent's review and opinions.
7. All literature, standards, guidelines, texts, statute, regulations, rules, policies, procedures, protocols and the like, which deponent (a) has consulted in connection with his/her review, (b) relies upon, or (c) may otherwise use or refer to at the Illinois Department of Transportation hearing.
8. All bills, time records and other billing records pertaining to deponent's activities in the application to site a heliport.


