The project is located two miles southeast of Carbondale along Drury Road which is approximately one mile east of the Giant City Road in Jackson County. The work includes approximately 88,331 cu yds of earth excavation; 1,275 sq yds of stone riprap A-3; 2,906 sq yds of stone riprap A-4; 12,444 sq yds of special excelsior blanket; 121 tons of CA-1 chert for French Drains; installation of 25 feet of 48" diameter bituminous coated reinforced concrete pipe culvert and 1,739 feet of woven wire fence with 2 gates; construction of small inflow drainage structures; 6" PVC pipe drain system for water treatment cells; and seeding, mulch, and soil amendments for approximately 18 acres.
