001W LAKE MICHIGAN/CHICAGO RIVER LEAKAGE CONTROL ESTIMATE:  
COUNTY(IES): COOK

The project consists of repairing leaks from Lake Michigan into the Chicago Rive at the headland of the Chicago River. Due to site requirements, some of the work will need to be performed from a barge. Work will consist of furnishing and driving steel sheet piling, installing walers for the piling, filling behind some of the piling with lean concrete, boring and filling seepage control grout holes, underwater joint sealing (welding) for the existing steel sheet pile sea wall, pressure grouting, removal and replacement of existing riprap, removing and rebuilding some concrete cap on a seal wall and all appurtenant work required to complete the project located along the North Pier separating the Chicago River from Lake Michigan in Cook County, Illinois immediately south of Navy Pier; includes 58.3 cu yds concrete removal; 58.3 cu yds concrete structures; 160 ft steel piles HP 14x73; 4,036 sq ft steel sheet piling; 1 lump sum electric service relocation; 70 cu yds lean concrete fill; 200-foot underwater joint repair and 330 to 780 bags of pressure grouting.

002W CRYSTAL CREEK FLOOD CONTROL PROJECT PHASE IIA ESTIMATE:  
COUNTY(IES): COOK

0.40 mile of channel improvement on Crystal Creek beginning approximately 150 feet downstream of 25th Avenue and ending just upstream of Wehrman Avenue in Schiller Park, Illinois. Work consists of revising an existing channel with a varied side slope to a rectangular channel with an 18 to 28-foot side bottom and 9 to 12-foot tall side walls constructed of segmental concrete blocks. Seven existing pedestrian bridges will be removed and replaced with six PCC deck beam bridges 23 to 25 feet long and one culvert extension. Two stream crossings will have an additional box culvert barrel constructed and three crossings will have the existing culvert replaced with a double box culvert. The work will also include the removal of a garage and existing bridge abutments and all appurtenant work required to complete the project. Proposed work included 556 units tree removal (6 to 15 units diameter); 846 unit tree removal (over 15 units diameter); 2,339 cu yds channel excavation; 50,000 lbs reinforcement bars; 700 sq yds stone riprap, Class A4; 324 tons stone dumped riprap, Class A4; 4,543 cu yds structure excavation; 60 cu yds concrete structures; 593 sq ft precast prestressed concrete deck beams (11" depth); 250 cu yds concrete box culvert; 50.5-foot precast concrete box culvert 10'x4' (M273); 229-foot precast concrete box culvert 10'x5' (M273); 3,088-foot chain link fence, 6'; 2,115-foot chain link fence to be removed and re-erected; 1 lump sum traffic control and protection, (special); 28,659 sq ft segmental concrete block wall and 1 lump sum temporary cofferdam system.
