The proposed reclamation project is located just east of Fiatt, Illinois. The work includes special clearing; approximately 935,750 cu yds of earth excavation; 581,492 cu yds of mine refuse excavation; 100,000 tons of coal combustion by-product placement; 1,279 sq yds of stone riprap A-4; 2,772 tons of aggregate surface course type B, CA-6; 300 tons of aggregate surface course Type B, CA-1; 236 feet of pipe culvert; treatment and dewatering of 4 impoundments; 2,512 feet of woven wire fence; and seeding, mulch and soil amendments for approximately 175 acres. A Pre-Bid meeting is scheduled for this project at 9:00 am Friday, July 24, 2009 at the intersection of East Arrow Road and North Arrow Road.
