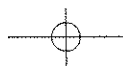

The amount of fine and costs are noted on the front side of the ticket in the "Bond" section on the "Total Bail" line.

NOTE: Payment must be by cash, money order, certified check, bank draft, or traveler's check unless otherwise authorized by the clerk of the court. (DO NOT SEND CASH IN THE MAIL; use cash only if paying in person.)

If you wish to plead "**NOT GUILTY**", complete the form entitled "Avoid Multiple Court Appearances" on the top half, of the back side, of the blue copy and follow those instructions.

BOND INFORMATION - FAILURE TO APPEAR

The type of bond you posted is marked on the front side of the ticket in the "Bond" section. The result of your failure to appear or pay this ticket is determined by the bond type identified below:
